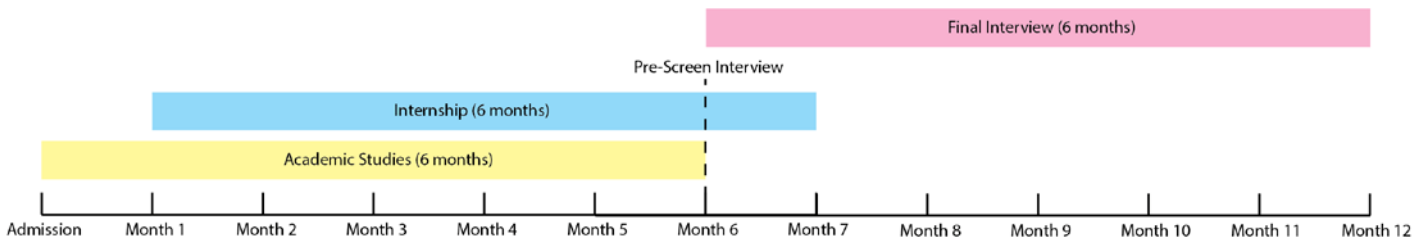

An interview will be held by the academic department prior admission. This is to ensure that the student speak fluent English & has outgoing personality.

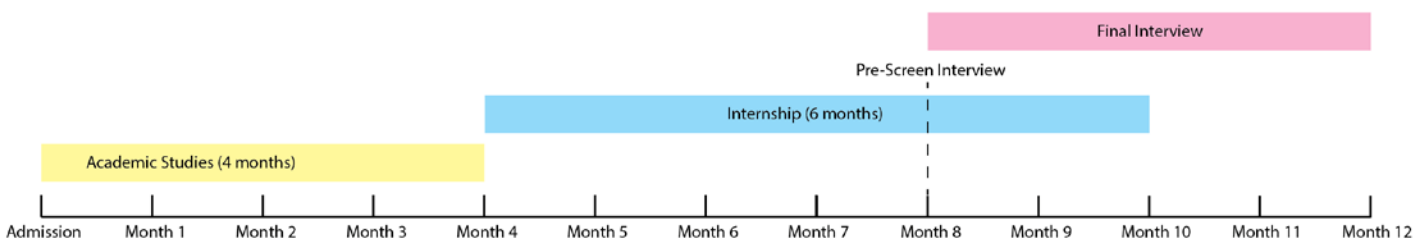
